- Marie Pinkney, our new State Senator, made her introduction via a cell phone to let us know she is grateful to represent us and is willing to work with us on any project. Read Scott, her Legislative Assistant attended on her behalf. The issue of speeding in the neighborhood was identified and she will request DelDOT to do a speed bump study again in our neighborhood.
- Our annual Yard Sale will take place **May 15 & 16 from 8am 3pm** on both days.
- Residents have witnessed suspicious activity in the neighborhood. If you suspect any dangerous or suspicious activity, call the Police non-emergency number **302-573-2800**
- Residents are concerned about the graffiti along the School Bell corridor. There used to be a Graffiti Brigade that provided paint to clean up. Chrissy Robert, assistant to George Smiley will provide information regarding graffiti. If you have information on how to get it removed, please let us know via the Facebook group.
- George Smiley was unable to attend. His Assistant, Chrissy Robert attended in his absence. Chrissy to provided information regarding the reassessment of properties in New Castle County. Properties have not been reassessed since 1983. The Court of Chancery has determined that NCC will need to reassess. The process will take at least three (3) years and property taxes will be adjusted. This will leverage the property taxes in NCC so that it is fair throughout.
- Several residents complained about the noise from the traffic on Route 1, especially since the addition of the new lane. Sound study was done 2 years ago and sound barrier was to be constructed. This topic will be revisited.
- To report a street light outage, contact Delmarva either online at **www.delmarva.com** or by phone at **(800) 375-7117**. The reporting requires customers to provide the utility pole number or an address for the streetlight.
- Be aware of parking along Dasher Ave bend. It is a tight space and it makes it difficult for emergency vehicles to come through if necessary. Consider staggered parking so cars are not directly across from one another.
- There is a Little Free Library located at 88 Dasher. Books are available. Take a book - Share a book! Free Little Library book-sharing boxes play an essential role in providing 24/7 access to books right in our neighborhood.

### I-95 CORRIDOR

As you may have already witnessed, the I-95 project has begun. The purpose of this project is to maintain and preserve the I-95 corridor in a state of good repair, ensure a 30-year service life extension, enhance safety and improve roadway efficiency to lessen traffic congestion. The project
